Thefts Of Bicycles

### GARDAI ON DUTY OUTSIDE CHURCHES

The authorities had taken such a serious view of the stealing of bicycles from outside churches that they had placed Gardai on duty at churches all over Dublin, said Detective-Officer Murphy at Dun Laoghaire.

Before the court was Patrick Roe, Montpeller Parade. Monkstown Road, Blackrock, who was convicted of the larceny of a bicycle, value 23, the property of Rose Flynn, Yankee Ter., Newtownpark, Blackrock, at Blackrock, on September 19, and illegal possession of various bicycle parts.

He was sentenced to six months' imprisonment with hard labour on the larceny charge, and one month for the illegal possession, the sentences to run consecutively.

It was stated that the accused had been seen loitering around the vicinity of the churches, and since his arrest no bicycles had been stolen from the churches.

# HARD LABOUR FOR CYCLE THEFTS

### JUDGE ISSUES WARNING TO RECEIVERS

When a youth named John Connor, Harold's Cross, was charged with stealing bicycles in the city, Judge Shannon said:

"I take a serious view of bicycle stealing, which, I understand, is very prevalent in the city. It seems very easy to steal bicycles and just as easy to sell stolen bicycles, and it is a most difficult crime to detect.

"I would be very happy to have any person convicted of receiving stolen bicycles before me and I consider that the only remedy is imprisonment."

The Judge imposed a sentence of six months hard labour on Conner.

# Advice to Cyclists COMBATING THE CYCLE THIEF

Don't leave your machine unlocked.

It's always worthwhile to turn the key in the lock, even if you'll only be absent a few seconds.

If you have forgotten your lock or key, deflate one of your tires and remove the valve.

Remember, a lock & key won't safeguard detachable objects such as a basket, a pump or a lamp.



# Between 2003 & 2013 <u>recorded</u> bike theft increased by 100%, with a sharp increase from 2009





# Only 1 in 6 reports a bike theft




# Under-recording in other European countries is between 4:1 and 6:1.



# We estimate that somewhere between 23,000 and 35,000 bikes were stolen nationwide last year




# 75% of total bike theft in Ireland occurs in Dublin






# ...so between 17,000 and 26,000 stolen in Dublin in 2013

# What the Gardai say

- Difficult to reunite recovered bikes with bike owners
- Non-reporting means difficult to prove suspected stolen bikes were stolen.
- When theft is reported, often no frame number.

# Case study Netherlands

#### Motivation for change:

Public anger led to govt action.

#### Goal:

Reduce thefts by 100k from base line of 763k.

#### Administrative approach:


- Dept of Transport chair group
- All stakeholders represented
- Centre for expertise established

#### Starting Point was a review of:

- Locations, times & profile of thieves
- Distribution channels for stolen bikes
- Attitude of public and police to bike theft



## Bike theft fell by 33% between 2006 & 2010



### Lessons from the Dutch

- Political will needed.
- State group (dept of transport) to co-ordinate work
- All stakeholders involved.
- Start with detailed analysis.
- Actions with greatest return.
- No single simple solution or `silver bullet`.





# Project Cycle Ops' London

#### Background

- Rising population
- Mayor `make London a cyclised city`
- Research showed bike theft a barrier to increased cycling

#### Research/Analysis

- No frame numbers for reported stolen bikes
- High re-sale value (bikes are CRAVED).
- Low detection rates and sentences

#### Size of the problem

- 100k thefts (25% reported 25k)
- 25% who had a bike stolen stop cycling (25k).

#### Specifics of London problem

• Avg re-sale value stg 275. Avg court fine: stg 150

# `Project Cycle Ops` Plan

#### Organisation

- Transport for London (TFL) co-ordinate
- Police, advocacy groups etc involved.
- 30 full time officers funded by TFL (2010-2013).

#### **Actions**

Identified and targeted high risk areas:

- Leaflets, stands with locking advice, stickers on bike stands ("lock it or lose it".)
- Bike registration events
- Web sites buyers and sellers guides

#### Bike Parking

Stands that have natural & formal surveillance etc.

# Bike Theft Campaign aims (1)

#### Highlight the extent of the issue

- Bike theft doubled in past 5 years
- Theft figure in Dublin approx 20k and not 5k reported
- Low conviction rates.

#### Provide advice for cyclists

- Use better locks no cable locks
- Know frame and model number & always report
- Don`t buy a stolen bike



# Bike Theft Campaign aims (2)

#### Recommendations:

- Code of practice for websites & bike shops
- Gardaí to give bike theft a higher priority
- More secure cycle parking

### But most importantly..

- State run committee needed to oversee work

# Dublin Bike Theft and Bike Parking Survey - Dublin Cycling Campaign

# Results

- 1,539 responses
  - 1,081 had a bike stolen
  - 458 submitted comments

#### Impact on cycling

- 1 in 6 victims (16%) don't replace bike (3k).
- A further 26% reduced amount cycled (5.2k).
- 42% therefore stop or reduce cycling (London comparable figure is 67%).

#### Locations

- Top 3 theft locations are:
- 1. Car parks
- 2. Home (house/appt/garden/shed)
- 3. Streets



# Results cont

#### Reporting

- 27% of people who reported thefts had frame number.
- 4% recovered stolen bike

#### Locking

- 11% didn't have bike locked.
- 44% had bike locked with a cable lock

#### Insurance etc

- 15% (c 1 in 7) had bike insured. (London figure is over 30%)
- 87% of those with insurance had home insurance
- 42% who replaced stolen bike got a used bike



# Results Bike parking

#### Parking


- 32% said they`d pay for bike parking
- A further 42% said they might pay.
- Of that 74 %, 3/4's said they'd pay Eur 2/day max.


#### The draw

- 14% said they wouldn't like to be included in the draw...
- 39% said they`d like to get involved in the campaign (609...)




# Bike theft locations from survey







# **Trinity College**

(1k responded, but 20k thefts..for each dot count 20..)






# George's st, South William St, Drury st

# Some comments from the survey

### On bike theft

- "Bike theft is rampant. I'd love to cycle to more places if I didn't think my bike would be stolen"
- "Am very careful & still have had 3 bikes stolen. Everyone I know that cycles has had bicycles stolen."

### On bike parking

- "Drury street is great but we need much more secure bike parking places in city including the Northside"
- "Much more on street bike racks. Often I cant find a place to lock my bike and end up locking to railings"

# Some comments from the survey

#### On Garda action

"Gardai don't take bike theft seriously. If this was car theft Guards would be all over it"

#### On bike locking

- "At all bike stands we should have: 1. Signs warning of bike theft & 2. Advice on best locking practices."
- "Owners have to take responsibility too. Get a better lock! Double lock! Watch what you lock it to!"



# INCREASED NUMBER OF OFFENCES

# ADVICE TO OWNERS

Every month sees an increase in cycling in the city, and most owners constantly are in dread of a thief. Most continental cities provide parking in bike parks free of charge or for a nominal fee, the parking stands being in the charge of an official, who gives a numbered disk to the owner after locking his bike in a bracket. Bicycle thefts in these cities were very uncommon as a result.

The principal places of larceny are outside shops, churches and offices where bicycles are left unlocked and unattended. A lock can be purchased for 3d and in the past 3 years only 1 bike was stolen that was locked.

Registration of bicycles on the lines of motor vehicles has been suggested as a means of checking farcenies.
