Public Transport-Bicycle relations

- Need to displace car parking by providing good active and public transport modalities
- Park-n-Ride is too expensive in land use terms
- Discourage multi-story car parks as a solution from now on
- Bike-n-Ride must be the preferred solution health, congestion, land use, etc superior
- Car-centricity does nothing for the poor or marginalised
- Far stronger political commitment needed to make cycling commuting work

Thomas Jouannot (CEREMA/DTecTV, FR) www.cerem.fr Study on tram and bicycle interactions

In France all Luas type tram systems permit bike carriage! In France only two possibilities:

Tram only along streets – no other vehicles permitted

Or

Open to all road users

But in reality operators and police have come to realisation that bikes and trams can co-exist so rare to see prosecutions for riders being on tram only routes

 We need to get out datum about 'external cost' to society of car use – €750/car/y

Alice Billot-Grasset (University Lyons, IFSTTAR/TS2/UMRESTTE)

"Typology of cyclist accidents"

- 4,500 RTCs involving cyclists in France/y (250 in Rhone-Alpes)
- Risk of serious injury to cyclists in FR is 8x other road users (2012)
- Cyclist-only accidents are just under 70% of total
- Impacts with vehicles approx 30% of total

Andrea Weninger (Vienna, AU)

"News about role of active mobility in resilient cities"

- Cycling makes cities resilient
- Vienna liveable, robust, prosperous, clean
- 15% of household income goes on transport
- Modal-share for cycling now at 6%
- Building code: 1 protected/secure bicycle parking slot per 30 m² of living space
